

Notice of FY2024 Support Benefit for Rising Prices of Goods (100,000 Yen)

- The Support Benefit for Rising Prices of Goods (100,000 yen per household) is a benefit provided to households that are newly exempt from resident tax or subject to per capita resident tax only in fiscal year 2024, utilizing the government's "Priority Support Local Allocation Tax Grant."

(Note) Households that were eligible for the FY2023 Support Benefit for Rising Prices of Goods (70,000 yen or 100,000 yen) will not receive this benefit.

- **Procedures are required in certain cases** to receive this benefit.

Amount of Benefit Payment

100,000 yen per household

Eligibility and Procedures for the Benefit

Eligible Households

Those that meet all of the following requirements

- Registered as residents of Suginami City as of **June 3, 2024** (Base Eligibility Date)
- All members are exempt from resident tax or subject to per capita resident tax only for fiscal year 2024 (before fixed tax reduction)

(Note) Households that were eligible for the FY2023 Support Benefit for Rising Prices of Goods (70,000 yen or 100,000 yen) will not receive this benefit.

1 Eligible households for which the head of household has a **registered bank account for receiving governmental allowances*** and for which no members moved into Suginami City on or after January 2, 2024
*A bank account for receiving governmental allowances is an account pre-registered through systems like Mynportal, etc. for receiving benefits and other payments.

No procedures required

A **Notice of Provision** will be sent to the heads of relevant households in stages, starting from July 25, 2024.

In principle, benefits will be transferred to the bank account designated for receiving governmental allowances.

Payments will be made in stages, starting from late August 2024.

2 Eligible households outside of category

Procedures required

From July 25, 2024, documents, including a Confirmation Form or an Application Form, will be sent in stages to the heads of relevant households.

***If you do not receive the notice, please contact the call center listed on the back page.**

Confirm the information on the back side before submission.

Payment will be made about one month after the submission of your documents.

Procedures (Only Applicable to Households under Category 2 on the Front Page)

If **no members** of your household moved into Suginami City on or after January 2, 2024

- Fill in the necessary information on the **“Confirmation Form,”** attach the required documents listed on the back of the form (such as a copy of the passbook showing the account for the transfer) and **return them.**

If **any member** of your household moved into Suginami City on or after January 2, 2024

- Fill in the necessary information on the **“Application Form,”** attach the required documents listed on the back of the form (such as a FY2024 Resident Tax Exemption Certificate issued by the municipality where the person who moved in resided as of January 1, 2024) and **return them.**

Electronic application forms are available for use

Both the Confirmation Form and Application Form can be submitted electronically using a smartphone, computer, or other device. Please access the website using the QR code on the right to apply.

Information on Payment of Additional Child Benefits (50,000 Yen per Child)

- Among the households eligible for the “FY2024 Support Benefit for Rising Prices of Goods (100,000 yen),” those with children 18 years old or younger as of June 3, 2024 (Base Eligibility Date) will receive an additional 50,000 yen per child.
- Information regarding the additional child benefits will be sent sequentially from late August 2024 to households that have already received the “FY2024 Support Benefit for Rising Prices of Goods (100,000 yen).”



Beware of **bank transfer scams** and **identity theft** related to the Support Benefit for Rising Prices of Goods for households exempt from resident tax, etc.!
