

Notice of Additional Child Support Benefit for Rising Prices of Goods (50,000 Yen per Child)

- The Additional Child Support Benefit for Rising Prices of Goods (50,000 Yen per child) for Households Exempt from residence tax, etc. for FY2024 is a special benefit provided by using the government's Priority Support Local Allocation Tax Grant.
- **Procedures are required in certain cases** to receive this benefit.

Amount of Benefit Payment

50,000 yen per child 18 years old or younger* (Provided on a per-household basis)

* Children born on or after April 2, 2006

Eligibility and Procedures for the Benefit

Eligible Households

Households eligible to receive FY2024 Support Benefit for Rising Prices of Goods (100,000 Yen)* that include dependent children 18 years or younger.

(Note) Households with a residence registration in Suginami City as of June 3, 2024 (Base Eligibility Date) and all members of the household are **exempt from resident tax** or **subject to per capita resident tax only**.

Further, households eligible for the FY2023 Support Benefit for Rising Prices of Goods (70,000 Yen or 100,000 Yen) are not eligible for this benefit.

Eligible households that received the Support Benefit for Rising Prices of Goods (100,000 Yen) for FY2024 **in the head of householder's account**

No procedures required (in principle)

Eligible households that received the Support Benefit for Rising Prices of Goods (100,000 Yen) for FY2024 **in an account other than the head of householder's account**

Submission of confirmation form required

Separate application procedures required for eligible households in the following situations

- Households with **children born on or after June 4, 2024**
- Households that **provide the livelihood of a child 18 years old or younger living in a separate household (dormitory, etc.)**
- Households with **dependents (for tax purposes) 18 years old or younger living in a separate Household**
- **Divorced households** or **households separated on the premise of divorce as of June 3, 2024 and living separately with a child under 18 years old, or households divorced on or after June 4, 2024 and living separately with a child under 18 years old.** *

* Applicable households are requested to contact the Call Center.

Procedure / Payment Period

Applicable households under **1** on front page



- A **Notice of Provision** will be sent to the heads of relevant households in stages.
- The benefit **will be transferred to the account** used to receive the Support Benefit for Rising Prices of goods (100,000 Yen) for Fiscal Year 2024.

Applicable households under **2** on front page



- **Documents including a Confirmation Form** will be sent in stages to the heads of relevant households.
- Complete the confirmation form, attach the required documents (such as a photocopy of the passbook verifying the account to which the benefit will be transferred) as indicated in the enclosed notice, and return them.

Application Deadline

Thursday, October 31, 2024
(must be postmarked by this date)

Payment will be made about one month after the submission of your documents.

For eligible households with children born on or after June 4, 2024

Q I am the head of a household that has already received the Support Benefit for Rising Prices of Goods (100,000 yen) for Fiscal Year 2024. My household includes children aged 5 years old and 3 years old as of the Base Eligibility Date (June 3, 2024). My household also includes a child born on June 4, 2024. What should I do to receive the Additional Child Benefit?

A Information on the payment date for the Additional Child Benefit for registered residents 18 years old or younger as of the Base Eligibility Date (June 3, 2024) will be included in the Notice of Provision. No further action is required to receive the benefit amount (100,000 yen) for the 5-year-old child and 3-year-old child. However, for the Additional Child Benefit (50,000 Yen) for the child born on June 4, 2024, you will be required to submit the Application (Payment Request Form) for Suginami City Support Benefit for Rising Prices of Goods (Additional Child Benefits). See the procedure for ③ above. Note that applications must be submitted by October 31, 2024, or the benefit will be forfeited.



Beware of **bank transfer scams and identity theft** related to the Support Benefit for Rising Prices of Goods for households exempt from resident tax, etc.!
